LEADING WITH FREEDOM IN MIND: A DIALOGUE ON
THE IGNATIAN LIBERATION JOURNEY



Annmarie Caño, Ph.D. is Dean of the College of Arts and Sciences and a Professor of Psychology at Gonzaga University. She is also a licensed clinical psychologist (MI, WA), spiritual director, and executive coach. Dr. Caño's work as an academic leader is informed by more than 20 years of higher education experience, her lived experiences as a Latina, first-generation college student, and a deep love and appreciation for Jesuit education and Ignatian spirituality. At the core of Annmarie's leadership philosophy is that leaders must work to create environments in which everyone, including themselves, can be more free to pursue the greater good through personal and structural change.

Dr. Caño earned her bachelor's degree in psychology from Princeton University (1993), and master's (1995) and doctoral (1998) degrees in psychology from Stony Brook University. Dr. Caño has served as principal investigator on four National Institutes of Health grants and is a Fellow of the American Psychological Association in two divisions (Society for Health Psychology, Society for Couple and Family Psychology). She grew up outside of New York City and served as an educator and leader at a public state university in Detroit, Michigan before joining Gonzaga in 2020. She enjoys spending time with her husband, middle schooler, and dog exploring the Northwest.

The Critical and Urgent Call to Rethink Women's Participation in the Catholic Church (Discerning Deacons) | Anna Robertson | Hemmingson Auditorium

What difference would it make in your life if women preaching in Catholic churches were the norm rather than the exception? If women participated in church governance at levels commensurate with their parish engagement? If women were ordained as deacons? Did you know that the Catholic Church is in active discernment about rethinking women's participation, and that you are invited to be a protagonist in that discernment? In this workshop, participants will learn about how the "critical and urgent" call to rethink women's participation emerged across every continent as a major theme during the first stage of the current global synod and be invited to explore how they can contribute to the ongoing discernment about the full inclusion and participation of women in the Church.
