

# **Pre-Law**

Gonzaga University's mission of preparing servant leaders committed to social justice means that Gonzaga pre-law students have many opportunities through coursework, co-curricular engagement, and professional development to think deeply about how they can pursue social justice and contribute to their community through the legal profession. Gonzaga pre-law, coordinated through Career & Professional Development, provides students with support, including presentations and one-on-one appointments, to help students learn more about law, whether a legal career is the right path for them, and how to prepare to apply to law school.

#### **ACADEMICS**

Law schools agree there is no single undergraduate major that best prepares students for law school. Thus, Gonzaga pre-law students are encouraged to major in any academic area of interest. Students preparing for law school should take courses that emphasize critical analysis of difficult reading material, logical thinking, and writing clear and effective prose. These skills are the tools needed to score well on the Law School Admission Test (LSAT) or the Graduate Record Examination (GRE) and meet the academic challenges of law school. Gonzaga's emphasis on teaching excellence means students can hone these skills in courses across a wide range of majors. Gonzaga also offers three experiential learning programs – Debate Team, Mock Trial, and Model United Nations – that allow students to put these skills into practice while learning about the law.

## GONZAGA PRE-LAW ADVISING

Resources available through Career & Professional Development (CPD) and pre-law advising include:

- Individualized support through 1-on-1 appointments
- Workshops and other events to help students gain knowledge about the legal profession and how to apply to law school
- Support with developing law school application materials including resumes and personal statements
- Opportunities to connect with alumni mentors in law school and the legal field

## **DISTINCTIVE OPPORTUNITIES**

#### **Internships**

Some students choose to pursue formal internships within the law profession. These opportunities include contact and experience with legal operations in the Washington State Attorney General's Spokane Office, the Washington State Legislature, the Spokane County Bar Association, and in the private sector at local law firms.

#### Collaborations with Gonzaga School of Law

The close proximity of the Gonzaga School of Law and ties to its faculty, staff, and students means pre-law students have access to a wealth of knowledge and experience about legal education and practice. Students have frequent opportunities to attend events, including the law school's annual Preview Day, and to sit in on law school classes.

#### Workshops, Panels, and Presentations

Each year, Gonzaga pre-law coordinates various events intended to help pre-law students understand more about the law profession and the process of applying to law school. These presentations, often co-hosted with law school representatives, include law career exploration, an overview of the law school admission process, and information about financing a legal education.
